#### **Proceedings**

Meeting called to order by Dean L. Gano; President, at approximately 6:40 p.m. Donna Sween was absent due to illness.

#### **New Business:**

The March meeting was canceled because we did not have a quorum.

Changing of the CCR's: The board discussed how to go about making changes to the CCR's and establishing rules. This is a continuing discussion from the February board meeting regarding establishing fines and fees. We also discussed adding a restriction on parking motor homes and large RV's in the side yards. Because of the controversy these issues had last summer, we decided to wait until we have the website up and running so we can have a blog type discussion on any changes to the Bylaws and CCR's. We will review the rules and regulations of other HOA's in the area and use them to provide ideas on how to proceed. Get feedback from the community and then make the changes.

**Status of the Website:** No action has been taken, but it was decided that we should proceed to buy a URL and use free software to develop it. Dean to take the lead on this.

**Reserve Study:** State law requires HOA's to hire a professional to evaluate an HOA's assets and make sure the HOA has enough reserve funds to maintain those assets. As advised by our attorney, the board voted not to perform such a study because it constitutes an unreasonable hardship upon the Association because of our limited budget and minimal assets requiring maintenance.

**Christmas Lighting Awards:** Approval was given to the Treasurer to send gift cards to the Christmas home light decoration winners.

**Landscape Maintenance Contract:** Approval was given to continue using Desert Green as our landscape maintenance contractor, but we also agreed to go out for bids every other year to make sure we are still getting the best price for the required services.

**Welcome Package Status:** Dean prepared and the board approved a welcome package to give to new members of our community. It is attached and will provide our new neighbors with a copy of the pertinent HOA documents and get their contact information. There are 9 new homeowners who need these and we will distribute to them soon.

#### **Treasurer's Report**

Bank balances were read and we have a healthy reserve. It was reported that two homeowners have NOT paid their 2016/2017 dues. One of them has sold their house and we will collect from the title company. The other one needs to be contacted and told to pay up or a lien will be placed on their property. Donna will contact them soon.

#### **Action Items:**

- 1. Dean to proceed with buying a URL and building a website for the HOA.
- 2. Marilyn to get an officially signed copy of the HOA bylaws so we can include it in the new welcome package.
- 3. All board members will hand out the new welcome packages to the 9 new HOA members who have joined our community since last summer. Marilyn to send these new member's names and addresses to other board members as agreed to in the meeting. Dean to have copies of the new package made and give to each board member for distribution.
- 4. Talk to new homeowner at 1311 Jubilee St. about prorated HOA dues. Who is going to do this?
- 5. Dean to call City of Richland Joe Schiessl and get status of surveying the entrance corner and deeding it to the HOA.

#### **General Discussion**

We still have a need for two more committee members on the CC&R Committee, volunteers needed. The next meeting will be held on May 14, 6:30 pm at Gano's residence, 1327 Jubilee Street.
